5. All other documents, produced by the Plaintiff in discovery shall be deemed Confidential, and shall be subject to the terms of the Confidentiality Order, but Ms. Colón shall not be prohibited from posting any such documents if she obtains them from another source.
 6. A copy of this Order shall be served by Ms. Colón's counsel upon all counsel of record, within 7 days of its entry.

1. Plaintiff's Cross-Motion to Designate as Confidential Certain Discovery Materials is hereby **GRANTED**.


