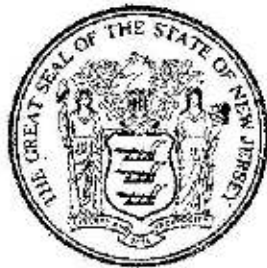

**Additional Articles/Provisions:**

12. NO PART OF THE NET EARNINGS OF THE CORPORATION SHALL INURE TO THE BENEFIT OF, OR BE DISTRIBUTABLE TO, ITS OFFICERS, DIRECTORS, TRUSTEES OR OTHER PRIVATE PERSONS, EXCEPT THAT THE CORPORATION SHALL BE AUTHORIZED TO PAY REASONABLE COMPENSATION FOR SERVICES RENDERED AND TO MAKE PAYMENTS AND DISTRIBUTIONS FOR EXPENSES INCURRED IN CONDUCTING ITS AFFAIRS AND CARRYING OUT ITS STATED PURPOSES. NOTWITHSTANDING ANY OTHER PROVISION OF THESE ARTICLES, THE CORPORATION SHALL NOT CARRY ON ANY OTHER ACTS WHICH NOT PERMITTED TO BE CARRIED ON BY A CORPORATION EXEMPT FROM FEDERAL INCOME TAX UNDER THE INTERNAL REVENUE CODE OF 1954 (OR THE CORRESPONDING PROVISION OF ANY SUBSEQUENT FEDERAL TAX LAWS).
13. THE CORPORATION SHALL INDEMNIFY EVERY CORPORATE AGENT AS DEFINED IN, AND TO THE FULL EXTENT PERMITTED IN SECTION 15A:3-4 OF THE NEW JERSEY NONPROFIT CORPORATION ACT AND TO THE FULL EXTENT OTHERWISE PERMITTED BY LAW.
14. NO OFFICER, DIRECTOR OR TRUSTEE OF THE CORPORATION SHALL BE PERSONALLY LIABLE TO THE CORPORATION FOR DAMAGES FOR BREACH OF ANY DUTY OWED TO THE CORPORATION, EXCEPT THAT THE FOREGOING SHALL NOT RELIEVE ANY OFFICER, DIRECTOR OR TRUSTEE FROM LIABILITY FOR ANY BREACH OF DUTY BASED UPON AN ACT OR OMISSION (A) NOT IN GOOD FAITH; (B) INVOLVING A KNOWING VIOLATION OF LAW; (C) IN BREACH OF SUCH OFFICER'S, DIRECTOR'S OR TRUSTEE'S DUTY OF LOYALTY TO THE CORPORATION; OR (D) RESULTING IN RECEIPT BY SUCH OFFICER, DIRECTOR OR TRUSTEE OF AN IMPROPER PERSONAL BENEFIT.
